On Thursday 9 March we mark International Women's Day with a panel discussion featuring stories of successful women at the Bar and how they got there.

The expression "nevertheless, she persisted" was coined in 2017 when US Senator Elizabeth Warren was forced to stop halfway through her speech but carried on, then was rebuked by Senator Mitch McConnel stating "she was warned. She was given an explanation. Nevertheless, she persisted." It subsequently became a feminist rallying cry around the world.

We adopt "nevertheless she persisted" to stimulate a discussion around women in law who faced barriers on their path to success but nevertheless, persisted anyway.

A rare opportunity has surfaced for MTYBA members to attend an upcoming Advocacy Training Weekend at Cumberland Lodge between 10 - 12 March. Bar Council Race Report and Racial Bias and the Bench



ONE YEAR ON FROM THE GROUND-BREAKING RACE AT THE BAR REPORT, THE BAR COUNCIL HAS PUBLISHED AN INTERIM PROGRESS REPORT ON ACTION BEING TAKEN ACROSS THE BAR TO ADDRESS RACE INEQUALITY.

We would like to draw to the attention of our members three reports concerning race inequality and judicial racial bias that may be of interest:

The Bar Council Race Report 2022

The Bar Council has now published an interim progress report on action being taken across the Bar to address race inequality.

The new report 'Race at the Bar: A progress report' summarises responses from 69 chambers and organisations across all circuits representing 4,306 self-employed barristers. The report highlights specific examples of action taken by chambers with a view to inspiring others to replicate effective action or to collaborate.

The Bar Council Race Report 2021

The ground-breaking Race at the Bar report 2021, addressed inequality at the Bar and

proposed a series of recommendations for action which can be found in the comprehensive Action Plan.

The report documents a range of statistics and personal testimony showing that for those who work at the Bar, their career is not purely based on an objective meritocratic evaluation of their ability.

A response to the Judicial Diversity and Inclusion Strategy 2020-2025

The report explores and evaluates racial bias as well as antiracism among the judiciary. and the fact that the judiciary of England and Wales have significant power, yet its operations are alarmingly under-scrutinised.

The findings are based on a survey of 373 legal professionals as well as existing research. Analysing the racial fairness of judges, racial guidance and diversity initiatives. The quantitative and qualitative data provides evidence of institutional racism in the justice system presided over by judges.
